



Viewing Attribute Codes on an OCF

In HCAI, health care facilities can utilize the attribute code field to identify remotely and/or virtually delivered services. As health care facilities shift the way service is provided to claimants/patients, the more attribute codes will be used to indicate that remote or virtual services have been provided on OCF's.

A description of the attribute code applied on an OCF is visible when the user hovers their mouse over an attribute code. This feature is available while creating an OCF, and when in review mode. This applies to all OCF's except the OCF-23 and Form 1 as they do not have attribute fields.

As a reminder, for Section 1, 6, and 7, the following attribute codes may be applied:

Code	Description
IN	Indirect (e.g. telephone, video conferencing)
SD	Self-directed (e.g. using tapes, videos)
